Introduction

Central Agency for Public Mobilization and Statistics (CAPMAS) works in the framework of republic's laws and decisions of organizing foreigners work in Egypt, So CAPMAS issue " Aggregate Study on Migration Statistics (2013-2017) "

I: Statistical Goal:

An Aggregate study that includes available statistics of foreigners in Egypt and Egyptians abroad during the period (2013 - 2017). It consists of several chapters, each chapter is a single unit for each statement in a special color and each chapter provides brief introduction showing the source of statement, the most important definitions and related laws.

III: Evidence and Classifications Used: -

Classification of Occupation: Occupational classification of 2005 which is derived from the 1988 International Standard Classification of Occupation (ISCO) "(1) four international digits, (2) coding occupations into six digits after slight modification to suit Egypt's conditions.

Industrial Classification (economic activities): use of Industrial Classification 2007 which is derived from International Standard Industry Classification (ISIC) - Revision 4- "first four international digits "tabulation categories and (2) in coding process at six digits level after slight modification to suit Egypt's conditions.

Administrative Classification: Administrative Classification has been used in coding statistical data geographically according to governorates, kism , Markaz and villages as well as new cities established inside all governorates.

General indicators

- Change of number of foreigners working in governmental sector and public / public business sectors during the period (2013-2017), which reached a maximum of 1132 foreigners in 2017, an increase of 27.3%. While the lowest number of 560 foreigners in 2014, a decrease by 41.4% from the previous year.
- Decline in the number of foreign workers in private and investment sectors during the period (2013 2017) with a maximum rise of 14699 foreigners in 2013, while the lowest decline of 13469 foreigners in 2017, a decline of 4.1% from the previous year.
- Decline in the number of foreigners who acquired Egyptian nationality during the period (2013 2017) with a maximum rise of 8907 foreigners in 2013, while the lowest decline of 2216 foreigners in 2017 by 10% over the previous year. Sons of Egyptian mothers married to foreigners are the main reasons for obtaining Egyptian nationality.
- Number of marriage contracts of Egyptian male with Arab women nationality was 12220, while cases of marriage with foreign (non-Arab) woman 12589 marriages cases by 0.3% and 0.3% respectively of the total number of marriages between Egyptians male during the period 2013-2017.
- Number of marriage contracts of Egyptian female with Arab husband's nationality was 7772 by 0.2%, while cases of marriage with foreign (non-Arab) husbands 2485 marriages cases by 0.1% Of the total number of marriages of Egyptian women during the period 2013-2017.
- Number of foreign births was 125 births (69 male births by 55.2% and 56 female births by 44.8%) in the period (2013-2017).
- Change of number of Egyptians with foreign nationality during the period (2013-2017), with maximum rise of 2331 Egyptians, an increase of 4% in 2017, while the lowest decline of 1704 foreigners in 2013.
- Fluctuation of number of Egyptian travelling abroad on scientific missions during the period 2013-2016, with maximum increase of 1021 Egyptians in 2016 by 21.5%, while the lowest decline was 560 foreigners in 2017, 45.2% higher than the previous year.
- International students represent the largest number of international students who graduated from higher education during the period (2012/2013-2016/2017), with a maximum increase of 5033 students in 2016/2017 by 85.8%, followed by Graduate students of private higher institutes and academies and finally graduates of technical institutes (government - private).
- Increase in number of international students who graduated from pre-university education (primary, preparatory, secondary) during the period (2012-2013/2016/2017), with a maximum increase of 88439 students for the academic year 2016/2017, an increase of 5.4% over the previous year. While the lowest decline was 41874 students for the academic year 2012/2013.



- Number of Egyptians arrival and departure during the period (2013-2017) reached a maximum of about 6.677 million Egyptians arrival in 2016 with an increase of 5.8%, compared to 6.801 million Egyptians departures, an increase by 1.2%. While the lowest decline was 5.517 million Egyptian arrivals, compared to 5.782 million departures in 2013.
- Decline in the number of immigrants who have acquired migrants status and, obtained approval of emigration abroad during the period (2013-2017), which reached maximum of 505 immigrants in 2014, by 17.4%, while decline of 348 migrants in 2017, a decrease by 5.2% from the previous year.
- The estimates number of Egyptians abroad is 10.247 million Egyptians in 2017. According to Ministry of Foreign Affairs, Arab countries represent the largest number of the total number of Egyptians abroad, reaching 6.985 million Egyptians by 68.2%

Chapter I

Foreign Employees in Governmental & Public/Public Business Sectors Some foreign experts may be consulted in the framework of laws and decisions governing the work of foreigners in Egypt (Law No. 137 of 1963 concerning the enumeration of competencies and scientific qualifications and inventions - Presidential Decree No. 114 of 1968 - Civil Employees Law No. 47 of 1978 - Law No. 5 of 1995 Article 74 and 98), which emphasizes the need to refer to CAPMAS before contracting the foreigner to verify absence of Egyptian experts in the type of work to be contracted, except for foreigners who come in implementation of international conventions or work not more than three months.

Collecting data from various republics' agencies (ministries - public authorities - governorates - public sector companies / public business) editor on form no. (309) for an inventory of foreigner employees in Egypt and their various characteristics included in general mobilization plans (excluding military experts) With inventory approvals granted by CAPMAS for foreigners to work.

Data on foreign employees in public / public business sectors are available in the "Annual Bulletin of Foreign Employees in Governmental & Public/Public Business Sectors " issued by CAPMAS.

Chapter II

Foreign Employees in private & investment sectors



Foreign Employee is not allowed to work in the country unless he obtains a license from the relevant ministry and he is authorized to enter the country and stay there for business purposes. Employers are not allowed to employ foreigners unless such license is obtained. The Country facilitate the procedures for foreign workers to obtain license to work in Egypt to small investors and establish small businesses in Egypt.

Foreign Employees data working in private and investment sector obtained work permits are collected from Ministry of Manpower and Immigration. Data are available in " Annual bulletin of foreign Employees in private and investment sectors" issued by CAPMAS.

Chapter III

Foreigners who have acquired Egyptian citizenship

Nationality is a political and legal association that binds an individual to COUNRTY and must become a member of its people, committed to its loyalty, in return for its obligation to protect him at home and abroad. The conditions stipulated by law are met. Naturalization is an application of one of the principles of international law which requires the right to change one's nationality (art. 15/2 of Universal Declaration of Human Rights of 1948).

Acquired nationality is the nationality established for an individual later on birth, even if birth is a factor in its acquisition. It is a nationality that is not imposed but selected, the desire of individual plays an essential role in gaining it, unlike the original nationality imposed upon individual upon birth.

Egyptian legislator identified three reasons for acquiring citizenship:

First: Children of an Egyptian mother who is a wife to a non-Egyptian husband before the date of enacting Law No. 54 of 2004. Anyone born to an Egyptian mother and a non-Egyptian father before the date of enactment of this law shall have the right to declare the Minister of Interior his desire to enjoy Egyptian nationality. From the date of the announcement without a reasoned decision. **Second**: Naturalization: Granted by a decision of Minister of Interior:

- I. Anyone born in Egypt to an Egyptian father of Egyptian origin when applying for naturalization in Egyptian nationality after making his normal residence in Egypt and was an adult at the time of application.
- II. Anyone who belongs to Egyptian origin when applying for naturalization in Egyptian nationality five years after making his normal residence in Egypt and was an adult at the time of application.
- III. Every foreigner born in Egypt to a foreign father who was also born therein, if this foreigner belongs to most of population in a country whose Arabic language or religion is Islam, when naturalization is requested within one year from the date of reaching the age of puberty.
- IV. Every foreigner born in Egypt, whose normal residence was at the age of puberty, when requested within one year of reaching the age of puberty, naturalization in the Egyptian nationality and met several conditions in accordance with law.
- V. By virtue of a decision by President of the Republic, Egyptian nationality may be granted without limitation to the conditions set forth in the preceding article of this law to any foreigner who performs great services to Egypt, as well as to heads of Egyptian religious communities.

Third: Marriage: A foreigner who marries an Egyptian shall not acquire his nationality by marriage unless she requested to obtain it to the Minister of Interior.

Foreigners who have obtained Egyptian citizenship are provided by Department of Passports, Immigration and Nationality - Ministry of Interior.

- (1) Egyptians working abroad in governmental and private sectors or with Egypt companies Is carrying out works abroad.
- (2) Egyptians who are abroad in scholarships.
- (3) Egyptians who work in diplomatic corps or international bodies.

Bulletin data is obtained from General Directorate of Work permits -Ministry of Interior, which is the basic reference for accounting Egyptians working abroad. It grants work permits to Egyptian nationals working for foreign bodies or entities outside the country (private -government).

Egyptians working abroad are regarded as timely immigrants. The Immigration and Care of Egyptians Abroad Law No. 111 of 1983 stated the following:

An immigrant is a time immigration for every Egyptian who is not studying, seconded or delegated to make his normal residence or the center of his activity abroad, and has a job to live from when he has spent more than one consecutive year abroad, even if there is a time interval not exceeding thirty days. Work permits data for Egyptians abroad is available in "Annual bulletin of work permits issued to Egyptians working abroad " issued by CAPMAS.

Chapter VIII

Egyptians acquiring foreign nationality

Citizenship is a political and legal association that binds individual to state and must become a member of its people, committed to its loyalty, in return for its commitment to protect it at home and abroad. Egyptian law allows Egyptian citizens to nationalize with a foreign nationality, with or without retaining Egyptian nationality after acquiring a permit issued according to a decision of Minister of Interior. In case of citizen's request not to retain the Egyptian nationality, he shall be deemed to have lost it since date of the ministerial decision or date of acquiring foreign nationality, whichever is later.

Data of Egyptians acquiring nationality of a foreign country is provided by Department of Passports, Immigration and Nationality, Ministry of interior.

CHAPTER IX

Scientific delegates sent abroad in scientific missions

Data for Egyptian delegates are provided by General management of Missions at Ministry of Higher Education.

Data for Egyptian delegates are available in "Annual bulletin of Delegates Abroad in Scientific missions". issued by CAPMAS.

A. <u>Foreign missions</u>: During which student receives a degree from one of universities abroad for a period of (3-4) years and delegation can return home during a certain period in order to learn and carry out the necessary field research.

B. Scientific missions: Scholarships are awarded in scientific missions in the form of grants to State or to sending party or personal grant either for training or scientific research purpose for a period from 3 months to one year.

<u>C. Scholarships</u>: Scholarship will be sent abroad to study or to collect scientific material for obtaining scientific degree or purpose of training and acquisition of expertise. It will be financed through foreign grants to state or to sending authorities or personal grants. The donor will determine duration of scholarship.

D. Joint supervision missions: During mission, student will receive a PhD from one of Egyptian universities under supervision of an Egyptian professor and a foreigner who will agree on the subject of study and research. The duration of mission will be five years. During which treatment of member of foreign mission materially, results saving study expenses and overcome problem of non-equivalence of some foreign degrees.

CHAPTER X

Egyptians movement across borders

Constitution stipulates freedom of movement, and recognizes the right of citizens to emigrate, where citizen has the right to obtain and carry a passport where those who have Arab Republic of Egypt nationality may not leave or return to Republic borders unless they hold passports. Such passports may be replaced by passes or leave.

Departure and arrival data are obtained through tabs prepared by General Directorate of Passports, Immigration and Nationality Department. Data are collected by its departments and units in the country's legitimate ports, which is to register every Egyptian who enters or leaves the country on special cards (arrival and departure cards).

Chapter XI

Egyptians who got approval to emigrate abroad



Data of Egyptians who have obtained permission to emigrate abroad, and Egyptians abroad who have acquired the status of migrants and who applied to be considered as migrants are based on the forms 348 and 349. Immigrant who comes from Passports, Immigration and Nationality Department at Ministry of Interior, and data is available in " Egyptians who have obtained approval for immigration abroad Statistical Bulletin " issued by CAPMAS.

Migrants: Those who left the country have an immigration license through legal channels according to Migration and Care of Egyptians Abroad Law No. 111 of 1983 (Article 8). "A permanent immigrant who has permanently made his habitual residence outside the country by acquiring the nationality of a foreign country or obtaining permanent residence permission. Or has resident there for a period of not less than ten years or has obtained permission to immigrate from one of immigration countries determined by Ministerial decree concerned with immigration affairs".

Original Immigrant: Is individual who submitted to concerned authorities to apply for a license to emigrate abroad, explaining his desire to accompany members of his family.

Immigrants who acquired immigrant status: Are those who left the country without an immigration license and then acquired the status of immigrant in Diaspora country

Companion: Is individual who has obtained a license to emigrate abroad following the original immigrant.
