22.5% patents granted to Egyptians in 2018

Central Agency for Public Mobilization and Statistics (CAPMAS) issued today, / / 2019, The annual Bulletin of Patents and Trademarks 2018, which aims to transfer knowledge, including patents, from technological information and making it available for scientific and technological development researchers to serve the objectives of economic and social development.

Bulletin Key Indicators are as Fellowes: Patents requested:

- Applications:

Applications patents requested for Egyptian Patent Office in 2018 reached 2255Application (997 applications for Egyptians by 44.2%, 1258 for foreigners by 55,8%), Compared to 2279 applications in 2017 (1025 Egyptians, 45%, 1254 foreigners, 55%), with a decrease of 1.1%.

– <u>Patent granted</u>:

Applications patents granted for Egyptian Patent Office in 2018 reached 690 (155 patents for Egyptians by 22.5%, 535 patents for foreigners, 77.5%) Compared to 581 patents in 2017 (96 for Egyptians by 16.5%, 485 for foreigners for 83.4% with an increase of 18.8%.


– Patents granted according to the International Classification:

– Humanitarian needs:

patents granted in the field of humanitarian needs reached 117 patents by 25.7% (27.7% for Egyptians, 72.3% for foreigners).

Chemistry and Mineral0s:

patents granted in the field of chemistry and metallurgy reached 152 by patents 22% of the total patents granted in 2018 (27% for Egyptians,73% forforeigners). patents granted in the field of formation and transport operations reached 112 by patents 16.2% (18.8% for Egyptians.81.2% for foreigners).



granted by Egyptian Patent Office, by 22.5%, followed by the United States America the total patents granted reached 149 patents by 21.6% and Japan by 68 patents where representing 9.9% of total granted patents in 2018.

Brands:

-Applications:

The Number of applications submitted to Egyptian Trademark Office reached 34629 applications for trademarks in 2018 by compared to 21859 applications in 2017, Increased by 58.4%.

The Number of applications submitted by Egypt for obtaining trademarks reached 21135, representing 61% of the total applications in 2018 compared to 14417 applications in 2017, an increase by 46.6%

-Brands granted:

Egyptian Trademark Office granted reached 8729 brands in 2018, compared to 4085 brands in 2017, with increase by 113.7%.

-Marks granted according to countries:

Egypt topped the list of brands with 6284 brands by 72%, followed by USA with 810, by 9.3%, and China with 210, representing 2.4% of the total number of trademarks granted in 2018.
